

AN ORDINANCE CLOSING AND VACATING CERTAIN
TOWNSHIP ROADS IN HAYCOCK TOWNSHIP

PROVIDING FOR THE CLOSING AND VACATING OF A CERTAIN
PORTION OF ROAD, BEING A PORTION OF THE BED of Township Road T424,
Haycock Township, between its intersection with Pa. Legislative
Route #386 (Route 563, also known as Ridge Road) and a point in the
corner of lands now or late of Philip J. Ries and Mildred S. Ries,
husband and wife;

PROVIDING FOR THE CLOSING AND VACATING OF A CERTAIN
PORTION OF ROAD, BEING A PORTION OF THE BED of Township Road T467
from its intersection with Township Road T424 to the boundary line
between Haycock Township and Nockamixon Township, the closing
and vacating of the same being in the best interest and for the
best convenience of the Township of Haycock; and the closing and
vacating of the same being pursuant to the laws relating to second
class townships in the Commonwealth of Pennsylvania.

IT IS HEREBY ENACTED AND ORDAINED by the Supervisors of
the Township of Haycock, Bucks County, Pennsylvania, and it is
hereby enacted and ordained by the same, pursuant to the laws
relating to Second Class Townships of the Commonwealth of Pennsyl-
vania, as follows, to wit:

SECTION I. Whereas, it is necessary in the judgment of
the Supervisors of the Township of Haycock, Bucks County,
Pennsylvania, to close and vacate pursuant to the laws of the
Commonwealth of Pennsylvania relating to Second Class Townships a
portion of Township Road T424 in the Township of Haycock, Bucks
County, Pennsylvania as more particularly described as follows:

NOW THEREFORE, said road is hereby closed, vacated,
and abandoned:

ALL THAT CERTAIN lot or piece of ground situate in
Haycock Township, County of Bucks, Commonwealth of Pennsylvania,
and described as follows:

Beginning at a point in the center line of the old and the new Legislative Route #386 (also known as Ridge Road and also known now and formerly as Route 563 and Legislative Route 386 PAR); thence along the center line of Township Road 424 N 53° W a distance of approximately 1,575 feet; thence N 27° W a distance of approximately 125 feet; thence N 43° W a distance of approximately 485 feet; thence N 38° W a distance of approximately 610 feet; thence N 13° W a distance of approximately 475 feet; thence N 9° W, a distance of approximately 600 feet, to a point designated by a railroad spike in the center line of said Township Road 424 (also known as Haycock Run Road), which railroad spike further designates a point, a corner, in line of lands now or late of Philip T. Ries and Mildred S. Ries, husband and wife, which railroad spike further delineates the northern terminus of Township Road 424 (Haycock Run Road) to be abandoned, closed and vacated hereby.

The total length thereof is approximately .73 miles, 3,858.7 feet, as determined by a straight line diagram dated September 22, 1973 and attached hereto and made a part hereof.

SECTION II. Whereas, it is necessary in the judgment of the Supervisors of the Township of Haycock, Bucks County, Pennsylvania, to close and vacate pursuant to the laws of the Commonwealth of Pennsylvania relating to Second Class Townships a portion of Township Road T467 in the Township of Haycock, Bucks County, Pennsylvania, as more particularly described as follows:

NOW THEREFORE, said road is hereby closed, vacated, and abandoned:

ALL THAT CERTAIN lot or piece of ground situate in Haycock Township, County of Bucks, Commonwealth of Pennsylvania, and described as follows:

Beginning at a point in the center of a stone masonry three arch bridge over Haycock Creek and being on the boundary line between Nockamixon Township and Haycock Township; thence along center line of Township Road 467 (Park Road) S 81° W; thence S 59° W; thence S 80° W the distance of 297.62 feet to a point in the center line of Haycock Run Road (Township Road 424) North of southern terminus of Township Road 424, also known as Haycock Run Road.


Total length equals approximately 297.62 feet, approximately .0568 miles, as determined by a straight line diagram dated September 24, 1973, and attached hereto and made a part hereof.

ENACTED AND ORDAINED into an Ordinance this 4th day of December, 1973.
